Applicants seeking priority consideration related to 1A. Advancing Equity and Removing Barriers or 1B. Population-Specific Organizations should answer the inventory questions in their entirety in the web-based form in JustGrants.

The questions are listed here to familiarize users with them prior to answering them in the JustGrants web-based questionnaire.

1A. Population specific organizations are nonprofit, nongovernmental, or Tribal organizations that primarily serve members of a specific underserved population and have demonstrated experience and expertise providing targeted services to members of that specific underserved population. (Some examples are organizations designed to serve Black or Latino communities; LGBTQ populations; disabled individuals; AI/AN communities; Asian American, Pacific Islander, and Native Hawaiian populations, etc.)

Which communities will have their needs addressed or will otherwise benefit from the proposed project?
